NOTE: ONE YEAR CONTRACT ending April 1, 2026 No Biomass Harvesting Allowed. Oak Wilt Restriction. CUTTING INSTRUCTIONS:

AREA A [Red Oak]: Harvest all merchantable oak and mixed hardwood within the designated boundaries except for 1) green marked trees (leave tree marking). 2) All conifers. 3) All aspen. All un-merchantable stems >1", except aspen and conifers, shall be severed. (27 acres)

AREA B [Northern Hardwood]: Harvest all orange marked trees between green marked gaps within the designated boundaries. Within the green marked gaps (120-160' canopy gaps) harvest all merchantable trees. (35 acres)

AREA C [Aspen]: Harvest all merchantable aspen and mixed hardwoods within the designated boundaries. Reserve trees include red pine and white pine. Aspen maintenance required. (3 acres)

Access:

- No new roads permitted. Reconstruction of existing woods roads will be needed.
- Landings shall be located where indicated on the prospectus map unless prior approval is obtained from county forest administrator.

Seasonal Restrictions:

- No harvesting activity permitted from April 1 through July 15. Oak wilt restriction.
- Dry summer logging chance. Harvesting operations allowed only when soils are dry enough to support equipment. Slash
 - Area A Proposed Oak burn site: No slash will be allowed within 10' of the residual trees and no large slash piles will be allowed onsite.
 - Area A & B Logger is encouraged to leave large tops on site away from residual trees.

BMPs

No slash will be left in any non-forested wetlands, ephemeral ponds, open water or designated stream channels. Do
not operate wheeled or tracked equipment within 15 feet of wetlands or 50 feet of ordinary high water mark of lake
except during frozen conditions.

Recreation

- Recreation trail surface will have to be restored to at least existing condition and any damaged signs/posts will have to be replaced by the contractor.
- Recreation trail shall be maintained snow covered during winter months and free of debris at all times.

All additional restrictions listed on the prospectus sheet apply unless otherwise specified.

MANAGEMENT CONSIDERATIONS

Area A: is a 92 year old red oak sawtimber stand scheduled for a shelterwood and root rake scarification timed with a good acorn crop. **Area B**: is a northern hardwood stand scheduled for a gap selection with single tree selection and root rake scarification in gaps to promote regeneration. **Area C**: is a 55 year old aspen stand scheduled for an aspen regeneration harvest. All areas are on level to gently rolling topography with some steeper slopes on silt loam and sandy loam soils with dry summer chance.
