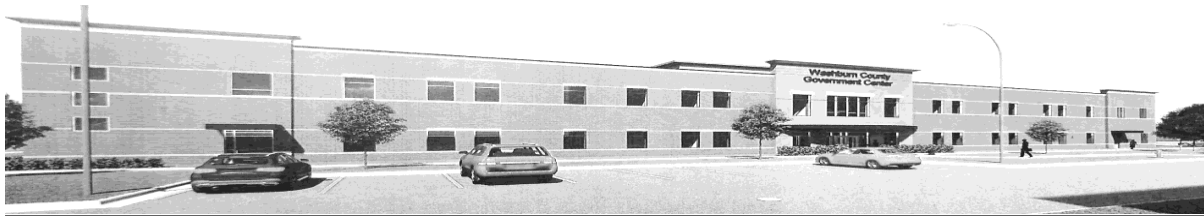

# **Washburn County**

## **The History**

Washburn County, located in the beautiful Northwoods in the northwestern part of Wisconsin, was created by an act of the Legislature in 1883. A territory of Burnett County was split to create one of the last counties in Wisconsin. Its namesake is in honor of Cadwallader C. Washburn, a former Governor of Wisconsin from 1872 to 1874 and a Union General serving in the Civil War.

During the early days of Wisconsin, the northwest territory of the state was the first home of the Sioux Indians and later the Chippewa Indians. Beginning in 1837, the Chippewa Indians made a series of treaties with the United State Government by which all northwestern Wisconsin was eventually ceded by the United States, with the exception of certain areas, now designated as “Reservations,” a home for the Chippewa Indians.

In the 1800’s Washburn County had a heavy growth of White Pine and Norway Pine, as well as species of hardwood and other timber. Logging started in the area during the 1860’s along the waterways and began its peak in the 1880’s. The primary waterways used were the Namekagon River, Totogatic River, and Yellow River because of their connection to the St. Croix and the Mississippi Rivers. The logs were floated to be milled into lumber in Stillwater, on the St. Croix River, and at times mills further down the river. The waterways also provided a great use for fur traders among other explorers and settlers in Washburn County.

## **Current Times**

Today, Washburn County has grown to 21 towns, two villages, and two cities; with an approximate population of 16,644. There are six school districts within the area which include, Birchwood, Hayward, Northwood (Minong) Rice Lake, Shell Lake, and Spooner.

There are a variety of industries represented throughout the County including manufacturing & fabrication, transportation, healthcare; but the top industries for the area would be a wide range of farming & agricultural, logging, and tourism. The logging industry continues to be a large revenue for the county, although the logs aren’t floated along the waterways anymore, they utilize local transportation businesses to move timber to mills around the state. There are many local farms and agricultural businesses such as cranberry marshes, dairy and beef cattle farms, berry farms, and even some agricultural tourism businesses.

Each year Washburn County has a substantial number of visitors to all areas of the county enjoying a wide variety of businesses within the tourism industry. Washburn County is well known for its vast amount of recreational opportunities.

Washburn County is also home to the Northwest District DNR, Wisconsin State Patrol, and is the Health Education Center for Northwood Technical College, formerly known as Wisconsin Indianhead Technical College (WITC).

## **While You're Here**

No matter which season you plan to visit Washburn County, there is a seemingly endless list of places to visit, trails to explore, events to enjoy, attractions to experience, and lakes and rivers to recreate on. Washburn County is home to nearly 1,000 lakes – 964 to be exact; over 100 miles of ATV trails, over 200 miles of snowmobile trails, over 130 miles of waterways, many trails for hiking, snowshoeing & skiing as well as mountain or fat biking trails. Washburn County is definitely an outdoor enthusiast's paradise!

Beyond the outdoors, each of the communities in Washburn County host events for all to enjoy such as Stone Lake Cranberry Festival, Spooner Heart of the North Rodeo, Birchwood Bluegill Festival, Minong Summer Days, Shell Lake Town & Country Days, Band on the Barge on Long Lake, among many other events!

Other inviting experiences aside from the many events are the local museums and attractions. Some of the most popular attractions include the Tommy Thompson Fish Hatchery, Railroad Memories Museum, Wisconsin Canoe Heritage Museum, Jack Link's Aquatic & Activity Center, Hunt Hill Audubon Sanctuary, Washburn County Historical Museums, Namekagon River Visitor Center, and the Shell Lake Arts Center.

The small-town businesses are what give each community in Washburn County its authentic hometown charm. Often when you go shopping whether at an art gallery or beautiful boutique, the owner will be the one behind the counter.
